A person who intends to apply under the application qualification items 9), 10), or 11) (on page 4 of the Application Guide for the first application round) must submit documents designated by the university to the admission office by 5 p.m. on Friday, January 5, 2024, for taking the individual enrollment qualification assessment prior to the application for the entrance examination.

(5) Application Documents

Applicants shall prepare the following application documents and must send by ordinary registered express mail. If delivered after the application period, the application cannot be accepted. Please send it ahead of time, fully considering the period required for mailing.

However, only ordinary registered express mail postmarked by the originating office on or before the day before the last day of “the application period specified in the item (3)” will be accepted even if it arrives after the deadline. Ordinary registered express mail postmarked by the sending office on the last day of the application period will not be accepted. (This is because it is certain that the documents will not arrive at the University within the application period.)

※ Exam Fee Exemption

For the purpose of reducing the financial burden on those affected by the Great East Japan Earthquake, TEPCO Fukushima Daiichi Nuclear Power Plant Accident, or the serious disasters such as the disasters caused by heavy rain to ensure opportunities for affected examinees to pursue higher education, the University will offer special measures to waive examination fees for all entrance examinations to be held in the 2023 academic year.

*3 Gathering time for the oral presentation and oral questions and answers shall be announced on “the admissions information” on the university’s website by the week before the exam date.
